- **Re: Call to oppose the EU Directives & Regulations : Codex Alimentarius.**

## INTRODUCTION

I am truly honoured to be invited to the 'plenary session' in Brussels today and hope to get the opportunity to meet with you. I would like to discuss the detrimental impact the EU Directives & Regulations, plus Codex Alimentarius will have on small health businesses, including healthcare practitioners, consumer rights & health choice. I hope to gain your support for our 'JOINING HANDS IN HEALTH' campaign, to urge the UK Government to **oppose** these legislations and in its place, establish an independent **Legal Health Framework** for the United Kingdom.

These EU legislations were conducted behind closed doors, without any form of consultation or consent from those it will affect the most (i.e. UK citizens)... who to this day have no idea of what is about to happen or how it will affect them, their children and future generations. They will be equally appalled to learn that their Government has (once again) sold them down the river by abolishing **Common Law**, leaving them exposed to abuse (i.e. 'criminalizing 'natural healthcare advocates').

To make matters worse, ancient cultural traditions used universally (such as African, Chinese and Indian practices), developed over centuries (and whose descendants are now UK citizens); are clearly being disadvantaged, disrespected and discriminated against, as most of their native produce and practices will also be banned thereby, denying their heritage.

This lack of transparency and secrecy will further increase distrust of the EU / UK Government and question their hidden agendas. The UK Government also openly pledged support for small businesses; encouraging innovative enterprise, placing healthcare as a top priority, whilst behind closed doors are introducing draconian laws. The CANCER ACT 1939 is a perfect example, which makes it illegal to claim that any **natural product (i.e. foods, herbs, remedies or supplements)** is beneficial for cancer. Even when proven 'safe, effective or if scientific evidence' exists, it is a **criminal offence** to produce, promote or sell it to cancer sufferers. The

majority of UK citizens are not aware of this unjust ACT. Therefore, people are suffering and dying needlessly from treatable conditions like heart disease, cancer, diabetes and lots more. Over 100 years ago these conditions were rare (due to the use of traditional foods & herbal supplements), but have now reached pandemic proportions with the use of conventional treatments. These laws make it impossible for consumers to openly choose or take full responsibility for their own lives. Just this month, a British gentleman has been committed for trial in the Crown Court for selling a 'safe, effective, non-toxic' herbal-product (from the Amazon jungle) to cancer sufferers; **not realizing it was a 'criminal offence to save lives by natural means'**. This gentleman had previously used the product to heal himself from cancer, after all conventional treatment had failed and was sent home to die. For the very same reason, my business (GRAMMA'S®) has also been forced to stop producing, promoting and selling a similar natural product... **with no right to appeal**. This is only the tip of the ice-berg which is mirrored throughout the UK. British citizens are being fined, imprisoned or both for healing their own people. As cancer is now affecting 1 in 2 of the UK population, this means it will affect at least one family member in every household. *So what would you do when it touches you or yours? OR how would you feel if a loved-one who has died... could have been saved?*

Our campaign aims to reveal these TRUTHS and encourage all UK citizens not to vote for any Parliamentary Member who does not show **open support** for protecting their health; and safeguarding the little rights we have left. Governments need to be reminded that they are elected to serve and protect the interest of their nation and not of themselves. Hence, transparency, honesty, consultation and consent are paramount in demonstrating fair-play in governance.
